Follow up is expected to be released in mid-to-late February. We will pass along more information as it becomes available.

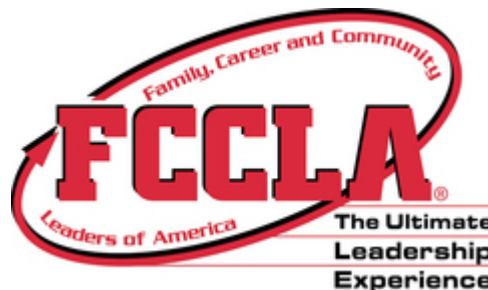
OAMCTE Essay Contest

Goodbye State Convention Tickets, Hello Wristbands!

All people wishing access to FCCLA General Sessions, workshops or exhibits must have an FCCLA wristband affixed to their wrist. This means every parent, adviser, student, bus driver, or guest must have their own wristband to gain entrance into any part of the FCCLA convention. Only chapters seated on the floor will have tickets in addition to their wristbands. Cox Center employees will be checking for wristbands as each person enters the arena or meeting room.
