# **National Leadership Conference**

As you and your students prepare to attend NLC be sure to have all of the required forms completed. FCCLA requires every student delegate (including guests) to read and complete the Code of Conduct Form, the Permission Form, and the Mandatory Dress Code Form. Chapter advisers (and/or chaperones) should collect and bring these forms with them to the

conference for possible reference. These forms can be found in the 2017 NLC Guide or in the Resources section of the FCCLA National website.

Starting at the 2017 NLC all chapter advisers/chaperones must complete the 2017 NLC Permission to Attend/Mandatory Dress Code Form that certifies that each student has completed and signed the forms listed above. Each adviser/chaperone must bring their signed 2017 NLC Permission to Attend/Mandatory Dress Code form to the conference in order to pick up their conference registration materials at the Registration Desk.
