Innovative Grants

There are only a few sections of the application that are required to be completed this year. Those areas include the requested funding amount, budget narrative, key personnel, and budget spreadsheet.

As you know, these grants are on a two year funding cycle. The funding for year two is contingent upon your school showing progress towards the goals listed in your initial worksheet.
