## FCCLA Meat Identification Competition – NEW

Oklahoma FCCLA, in partnership with Farm Bureau Women's Leadership Committee, is proud to announce the newest Oklahoma FCCLA competition: Meat Identification. This event, which will take place during State STAR Events, aligns with the iCEV Meat Selection and Cookery Certification curriculum. In addition to the test associated as part of the competition, Level 3 and 4 participants will also have the opportunity to take the American Meat Science Association certification test at no charge (regularly \$75 per person). They must make a 70% in order to receive the certification. Competition attire is listed in the rubric and is NOT chef or FCCLA attire, so please read carefully. This event is also an individual AND team event, in which individuals will receive first, second, and third place per level and overall teams will be awarded 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>.

## FCCLA Get SET Conference

FCCLA Speaking Excellence Training (SET) Conference dates and locations have been finalized! **January 11** – Life Church McAlester and **January 13** – Stride Bank Center in Enid. Cost is \$30 per student. Registration will open **November 1, 2021**. Each chapter may bring 10 students. Dress code is FCCLA conference attire OR FCCLA official dress. This conference is geared towards 7 – 10 grade students OR 11/12 grade students who have not competed in STAR Events prior to this year. This is a speaking conference – students will gain skills to help them compete in STAR Events and officer interviews. Registration will begin at 8:30 and the conference will take place from 9:00 a.m. – 12:00 p.m. Purchase orders should be made to: Oklahoma FCCLA. There is no cost for advisers. ## FCCLA Adviser Academy

For chapters who affiliated with the Up to 25 or Unlimited Affiliation packages, advisers are receiving a FREE Adviser Academy registration. The code will be sent from National FCCLA during the week of October 11-15. Registration deadline is **October 22<sup>nd</sup>**, so don’t let Fall Break make you miss your deadline. Chapters that did not choose a package may still participate, with the rate of \$90 per course. The Adviser Academy is a great way to grow your knowledge and FCCLA chapter, learn work-life balance, develop virtual learning lesson plans, network with other advisers, gain year-long support from National FCCLA, and more!

Graduates from the new Adviser Academy will be recognized at the 2022 National Leadership Conference and will receive an FCCLA certificate of completion, and two Continuing Education Units (CEU).

Additionally, participating advisers will have the opportunity to build a strong relationship with their state adviser and be engaged at the state level.
