"That's a Wrap" – BMITE Day at the Capitol

The first in-person, post-COVID BMITE Day at the Capitol was held on April 7, 2022. The event brought out nearly 310 teachers and students to the Oklahoma State Capitol to learn about government, tour the State Capitol and talk with State House Representatives and State Senators.

The event was put on for the BMITE programs across the state by the OkACTE BMITE division. The goals were to provide an educational experience to the students to learn about state government, allow them the opportunity to see state government in action, and relate government in action with the importance of how it affects citizens, towns, cities, and organizations (schools). Likewise, this event was also an opportunity to show a representation of the business, marketing, and information technology education programs across the state to Representatives, Senators, and other elected officials why it is essential to support education.

Several students started the day at 8:00 AM in a standing-room-only Supreme Court Hallway, and listened to OkACTE Executive Director, Skye McNiel, speak about OkACTE and CareerTech education. BMITE packed the Senate and House galleries at 9:30 AM to be recognized and hear introductions on a light legislative session by CareerTech supporters Senator Brenda Stanley (District 42) and Representative Dick Lowe (District 56).

After the session adjourned, many schools spoke one-on-one to their government officials at their Capitol offices. Many were able to experience the tours of the building and learn more about Oklahoma history and this historic building. Several students and teachers mentioned they were glad the BMITE Teacher's division of OkACTE brought this free event back.


If you have not booked your hotel room, grab one soon! If the website says they are full, call the hotel. They have been experiencing website issues.
