Oklahoma FCS teachers may apply to the Oklahoma Pork Council to receive funding for the purchase of Pork to be used in culinary, food services and consumer education courses.

Key Timeline Milestones:

- APPLICATIONS MUST BE POSTMARKED BY **September 15, 2022**. Applications will be reviewed and notification will be made by September 22, 2022.
- Funds are awarded on a reimbursement basis to the school - post cooking class. Activity must be completed prior to December 16, 2022.

CareerTech awards \$4.5 million in lottery grants, scholarships

The Oklahoma Department of Career and Technology Education has awarded more than \$4.5 million in lottery funds.

CareerTech awarded \$2,064,816 in grants to 26 technology centers for the 2022-23 school year and \$2,056,516 in grants to K-12 school districts for the 2022-23 school year, along with 388 scholarships worth a total of \$400,150 for the 2021-22 school year.

“These funds from the Oklahoma Lottery will benefit instructors and students throughout the CareerTech system and help us fulfill our mission to give students the skills they need to enter the workforce and make informed career choices,” said Lee Denney, CareerTech’s interim state director. “Through the competitive grant process, there is a direct investment in classroom and training experiences, including new equipment, technology and enhanced instructional resources.”
