

Access to 5-Year Program Evaluations on the new and improved ctYOU.org site: You must still log-in to view/edit your folder. After logging in, you should be able to click the "My Courses" dropdown list and find the link to the site. Otherwise, you can scroll down the ctYOU.org landing page and click FCS > 5-Year Comprehensive Evaluations. On that page, click the blue/green rectangular artwork OR the Program Evaluations title to access the site.

Once in the site, you can either scroll down the left OR center column to locate the folder for your school. You can also find it by doing a search on the page using your school's name. One thing to note is the Sharing Cart feature seems slow to load. If this is the case for you, you may want to click on your school's folder link in the left column. This seems to shorten the load time.
