NLC Intent to Compete Form

Make sure your NLC qualifiers complete their intent to compete AND Champ Camp registration from their NLC qualifiers letter. If they've lost their letter or you don't have one nearby, here's a link to complete the intent to compete and Champ Camp registration.

If your student received a letter stating they are eligible to compete at NLC, please complete the Intent to Compete form by April 14, whether they are going to NLC or not. Failure to do so by April 14 will signify they are not competing and we will notify the 3rd place entry if they are eligible to attend.

All NLC information has been posted to the Oklahoma and National FCCLA websites. The Oklahoma package is required for all members and advisers traveling to Washington, D. C. The package is optional for anyone not traveling but wants the great merch! Deadline to order is April 24, 2026. This is paid to Oklahoma FCCLA. National registration is paid to National FCCLA and hotel is paid directly to the hotel. Please make sure you have all purchase orders made to the correct payee.
